- 4. PLEASE DESCRIBE THE DOMAIN BRIEFLY. Ngorongoro District is among the seven Local Government Authorities of Arusha region which is situated as far as 424 km from the Regional headquarters in Arusha Town. The district boarders are

Monduli district along the East, Shinyanga and Mara Regions along the west, the Republic of Kenya (Narok and Kajiado Districts) along the North, and Karatu and Monduli districts along the South.
